By registering for the Commonwealth Prevention Alliance (CPA) 2025 Conference, and for and in consideration of CPA allowing me to register, attend, and participate in the Conference, I, for myself and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal personal representatives, executors, administrators, successors and assigns, hereby agree to release; waive; covenant not to sue; and assume all risk of transportation, attendance, or participation in any or all activities of the Event. I further agree to indemnify, defend, and hold harmless CPA, its employees, officers, contractors, directors, administrators, agents, instructors, speakers, members, other participants, sponsoring agencies, hosting hotel/convention center/venue—all of which are hereafter referred to as “Released Parties”—from any and all liability for any and all claims; judgments; costs, including attorney's fees; demands; losses; or damages on account of injury, death, or damage to property incurred in connection with any action brought in any way connected with the Conference, except when caused by the negligence of Released Parties. This agreement is specifically intended to operate as a waiver of liability to the fullest extent allowed by law. I hereby acknowledge that I have read and agree to be bound by the terms of this Release.

I consent to receive communications from CPA by e-mail. I agree that all agreements, notices, disclosures and other communications provided by CPA satisfy any legal requirement that such communications be in writing.

I also agree not to allow any other individuals to attend the conference in my place. I consent to CPA using any photos, other images taken of me, and any results of conference related activities that occurred during the conference for media outreach efforts, promotional campaigns, social media messaging, various publications/communications, or other business purposes as determined by CPA.

In the event that CPA should find it necessary to cancel or postpone this conference for any reason, including but not limited to low registration, strikes, acts of nature, war, terrorist's acts, or other circumstances beyond CPA's control, then CPA liability shall be limited to refund of registration fees paid to CPA.
